5 Y 6 NOVEMBER, 2014
BUENOS AIRES, ARGENTINA

This new Regional meeting has a special relevance to facilitate the continuity of the strategic process oriented to consolidate a GC Global-Local Identity in the latin American context and optimize the impact of the business commitment with the 10 principles in corporate stainable value generation.

This process initiated in 2013 Regional Meeting in Medellin works in three main axis:

- The Corporate sustainable value generation Agenda, identifying opportunities in the local contexts through the lenses of the Architecture. Contributing to build a Global Compact Agenda from the local contexts in a bottom up approach. In this context the new Post 2015 Sustainable Development Agenda and the role expected from companies to play in it presents a relevant value generation scenario to be analyzed in each of our local contexts.
- To reinforce the Global-Local identity and optimize the transformative potential of GC it is fundamental to put in place a most functional governance infrastructure of the initiative. In this sense during our meeting we will have the chance to present and discuss upon the tools developed to facilitate the best Articulation between Local Networks and UNGCHQ.
- The third axis to optimize the transformative Agenda is to achieve a relevant critical mass of companies through a Locally and Globally coordinated approach to growth, as well as the financial sustainability of the whole initiative , both locally and globally.

The proposal of this Agenda won't meet its targets if it is not approached in a double-way interaction , where Global issues are discussed in each local reality as well as each local reality is feeding the Global discussions. Local Networks will have the space to discuss among them and with the UNGCHQ about each of the topics which will be jointly suggested.

This way the discussion slots which will follow each of the presentations will be key to achieve the full value of this Regional Meeting.

The last session will consist in a Capacity Training on the 10th Principle, facilitated by the German Local Network in collaboration with the Argentinean.
